## Release of Liability and Waiver of Claims

**This Waiver and Release of Liability (the “Agreement”) is entered into on \_\_\_\_\_ by and between Stella Rossa Football Club, its staff, coaches, volunteers, and affiliates (collectively referred to as “the Club”), and the undersigned parent or legal guardian (the “Parent/Guardian”) of the minor participant (the “Player”) named below. By signing this Agreement, the Parent/Guardian agrees to the following terms and conditions:**

### 1. Acknowledgment of Risks

The Parent/Guardian understands and acknowledges that participation in the soccer experience organized by the Club involves inherent risks, including but not limited to:

- Physical injury, including sprains, strains, fractures, concussions, or more severe injuries;
- Travel-related risks such as accidents, illnesses, and exposure to disease (including COVID-19 or other infectious diseases);
- Risk of lost or delayed luggage, flight cancellations, and passport or visa issues;
- Medical treatment needs during travel or while participating in the event.

The Parent/Guardian accepts and assumes all such risks and agrees that the Club, its employees, coaches, agents, sponsors, and volunteers will not be held liable for any injury, illness, or loss that may occur during the travel or participation in the experience.

### 2. Release of Liability

The Parent/Guardian, on behalf of themselves, the Player, and their family, hereby releases, discharges, and holds harmless the Club and its affiliates from any and all liability, claims, actions, or damages arising from any incident, injury, illness, or other risks that may occur during the experience, travel, or related activities, whether caused by the negligence of the Club or otherwise.

### 3. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario. If any provision of this Agreement is found to be invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect.

### 4. Medical Authorization

In the event of an emergency, the Parent/Guardian grants permission to the Club’s coaches, staff, or any attending medical personnel to provide immediate medical care for the Player, including but not limited to first aid, emergency treatment, and transportation to the nearest medical facility, if necessary. The Parent/Guardian affirms that the Player has adequate medical insurance to cover any medical treatment or expenses while traveling abroad. The Parent/Guardian agrees to be responsible for any medical expenses incurred during the trip.

### 5. Health and Medical Information

The Parent/Guardian agrees to provide complete and accurate medical information regarding the Player, including any known allergies, medical conditions, or medications currently being taken. The Parent/Guardian understands that failure to disclose important medical information may affect the safety and well-being of the Player during travel and participation.

### 6. Travel Risks

The Parent/Guardian acknowledges the potential risks associated with travel, including flight delays, travel disruptions, customs issues, and health concerns related to local environments. The Parent/Guardian agrees to bear responsibility for ensuring that the Player has proper documentation for travel (e.g., passport, visa, travel consent forms) and for making arrangements for adequate travel insurance coverage. The Parent/Guardian also acknowledges that the Club will not be held responsible for any disruptions in travel arrangements or any medical quarantine or testing requirements, or other health protocols.

### 7. Code of Conduct

The Player agrees to comply with the Club’s code of conduct, both during the experience and while traveling. The Player understands that failure to adhere to these standards may result in disciplinary action, including possible expulsion from the experience or travel group. The Parent/Guardian acknowledges their responsibility for ensuring that the Player behaves in accordance with the expectations set by the Club, coaches, and experience organizers. The Parent/Guardian further agrees to support the decisions of the

coaching staff and travel organizers regarding disciplinary actions for any behavior that jeopardizes the safety, well-being, or experience of the Player or others.

**8. Photo and Media Release**

The Parent/Guardian grants permission for the Player's image, voice, or likeness to be used in photographs, videos, or other media for the purpose of promoting the Club, the experience, and future activities. This includes use in social media, websites, and other marketing materials. If the Parent/Guardian does not consent to the use of the Player's image, they must provide written notice to the Club prior to the start of the event.

**9. Financial Responsibility**

The Parent/Guardian acknowledges responsibility for all costs associated with the Player's participation in the experience, including but not limited to registration fees, travel expenses, accommodations, meals, and personal expenses. Refund policies for cancellations or no-shows are outlined separately and are acknowledged by the Parent/Guardian. The Club will not be responsible for any financial loss resulting from circumstances beyond the control of the Club, including but not limited to illness, travel restrictions, or personal emergencies.

**10. Club Membership Fees**

The Parent/Guardian acknowledges that all annual Club membership fees must be kept current prior to the Player being allowed to travel or participate in any organized Club experience, including the experience. The Parent/Guardian agrees to ensure that the Player's membership status is up to date and that any outstanding fees are settled before the departure date. The Parent/Guardian understands that failure to comply with this requirement may result in the Player being excluded from experience, and any funds already paid towards the experience may be applied towards the Player's annual membership fees rather than being refunded.

**11. Compliance with Local Laws**

The Parent/Guardian acknowledges that while participating in the experience, the Player and their family members must comply with all local laws and regulations in the host country. The Parent/Guardian agrees that the Player will respect cultural differences and abide by the rules set by the experience organizers, local authorities, and the Club.

**12. Acknowledgment and Agreement**

By signing below, the Parent/Guardian acknowledges that they have read and understood the terms and conditions outlined in this waiver and release of liability. The Parent/Guardian agrees to fully accept the risks involved in travel and experience participation and to hold harmless the Club and all affiliated parties from any and all liability arising from the Player's participation in the event.

This waiver shall be binding upon the Parent/Guardian and their heirs, executors, administrators, and legal representatives.
